MAYOR'S REPORT: Mayor Antoskiewicz briefly went over 20-51 – One Ohio MOU. He stated that those who were not on Council, 2 years ago we had got into an agreement to file a lawsuit along with a lot of other communities over the opioid crisis that had been going on. What has recently come up is One Ohio, the Governor decided that they would like to put all of the lawsuits together into one, figuring that they could make a better deal that way for everyone. If you the One Ohio legislation, it does not forbid us from getting out of the lawsuit that we are presently in. we can continue to do that as well, but to sign on to this memorandum puts in place that if this One Ohio successfully negotiates money, that we will be a part of it. It doesn't give up any rights we have now under the lawsuit we filed almost 2 years ago for this opioid crisis. I

would like to sign onto this memorandum so we can be a part of just in case Governor DeWine winds up getting us money. The best part is, it doesn't take us out and doesn't give us any liability from our other lawsuit, which we are in with some other communities.

DEPARTMENT HEAD REPORTS: Mr. Dean stated we have our final reading on the budget ordinance tonight and would like to thank Council for their input and their due diligence on this final budget. We did have some additional questions that he has been able to get answers on. He would like to go over, just a basic overview of the questions. Some of the Police Department with overtime, also on the markets and their affect on the city. He stated he was able to answer the questions and would be happy to share that with Council. There are 2 amendments that came through; 1 was to add some money for a storefront grant program and 2 changed our purchase for a vehicle. We actually found some savings, thanks to Council we saved about \$15,000.00. This is 2nd amendment for the Recreation Department. He would like to thank Council for the reviews that we had earlier and hopefully everything can pass tonight.

Mr. Dean stated we had a capital item for a police server. We corrected that to the correct amount which was lower. There were other items in that account that is getting spent for the Police Department basically for their operations. We have had a similar amount last year of \$29,000.00 last year, so only \$7,600.00 is going to be spent on a server, licensing for the Police Department permit. Just to clarify it is all not for a server.

MISCELLANEOUS:

Debbie Darling, 14149 Pinecrest Drive, stated the reason why she is here is that she went to

Royalwood Plaza on February 22nd and entered a drive off of Royalwood Road and damaged a part of her bumper. It has come to her attention that when contacting the Mayor, her Ward Council Representative no one has returned her phone calls. She stated she went to the Building Department and Inspector Smerek told her that they have received hundreds of phone calls about this situation; many people damaging their cars. The permit states this was poured in 1992 and if you look at the apron of this parking lot you will see multiple gauges and marks from many vehicles, probably thousands by now. She was told that you just go to civil court, but this is beyond the purpose of getting my car fixed, this is a principle getting it fixed. This poses a safety hazard to both people and their property, which she was told by the Building Inspector that they have been aware of this since day one. The Building Inspector, when it was poured, he passed it and unfortunately didn't want to pass this cost onto its owner and the city didn't want to absorb the cost she assumed. Nothing has been done. She was told by the Building Department knowingly know about this has existed for an ungodly amount of years now and this apron is still going to be there, most likely for another 10 years. We are going to wait until it crumbles and then we are going to have them replace it. So, you stop and you think, how much money to replace that apron, as opposed to all that damage this has caused. She was told it doesn't matter, the people of the city are aware of that and they don't use that drive anymore. Well if you are not from North Royalton...so they are just going to leave it. She suggested they put a notice up and she assumes no one wants to put one up because they would have to assume some liability and acknowledge. The people at the plaza that work there have told me how they have had their cars damaged over the years. How they have multiple customers come in their businesses over the years and complained. They have complained also to the property manager over and over again for nothing to happen. This is just being pushed under and all of these poor people are told to take it to civil court and file a civil claim. I think this is just negligence and it is hurting the people of this city, this county, anyone that goes there. People have to go there; they aren't going there just for fun. People have to go there by law and this needs to be addressed.

Mr. Marnecheck asked if Ms. Darling was able to stick around after the meeting. She stated yes.
