ORDINANCE NO. 19-14

INTRODUCED BY: Mayor Stefanik

AN ORDINANCE AUTHORIZING THE PROVISION OF CERTAIN AMENITIES TO CITY EMPLOYEES AND VISITORS, AND DECLARING AN EMERGENCY

WHEREAS: The Council of the City of North Royalton desires to provide to its employees and visitors certain amenities such as, but not limited to, coffee, tea, bottled water, and condiments, for daily use and at certain meetings and functions; and

WHEREAS: The provision of such amenities, as referenced, is hereby declared to be for a proper public purpose; and

WHEREAS: The disbursement of public funds for this declared purpose shall be from the General Fund.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. The Mayor is hereby authorized to approve the expenditure of public funds for the purpose of providing certain amenities such as, but not limited to, coffee, tea, bottled water and condiments, for the employees and visitors of the City of North Royalton.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 3. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that it is immediately necessary to authorize the disbursement of public funds for the above declared purpose.

THEREFORE, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
