

The Council of the City of North Royalton met in the North Royalton City Hall Council Chambers, 13834 Ridge Road on **March 28, 2013 in special session**. The meeting was called to order at 6:00 p.m. by President of Council Larry Antoskiewicz and opened with the Pledge of Allegiance.

SPECIAL MEETING ITEMS:

Mr. Antoskiewicz explained that all three candidates for the vacancy in Ward 3 have been interviewed and have been deemed qualified for the position. Therefore, Council declares upfront that all three candidates are eligible for election this evening. At this time, will the Director please ask each Council Representative to vote for his candidate of choice by stating the candidate's name.

Mr. Antoskiewicz announced that the vote has resulted in a 3/3 tie.

Mr. Antoskiewicz stated that since it is Council's duty under the Charter to make the decision regarding the filling of a vacancy, and since there is insufficient time left in which to meet again in order to accomplish this task, he moved to **recess into Executive Session pursuant to Ohio Revised Code 121.22 (G)(1) to consider the appointment of a public official**. Mr. Antoskiewicz explained that after the Executive Session, we will reconvene and vote again. If there is still no majority reached for a candidate, we will adjourn. Seconded by Mr. Kasaris. Roll Call: Yeas: **Five** (Antoskiewicz, Nickell, Marnecheck, Muller, Kasaris). Nays: **One**. (Petrusky). **Motion carried.**
