FIRST READING CONSIDERATION

RESOLUTION 19-58

Introduced by: Mayor Stefanik. **A RESOLUTION ADOPTING THE DOCUMENT CONTAINING THE ALTERNATIVE TAX BUDGET INFORMATION FOR THE CITY OF NORTH ROYALTON FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2020, AND SUBMITTING THE SAME TO THE AUDITOR OF CUYAHOGA COUNTY, OHIO, AND DECLARING AN EMERGENCY.** Title read.

MAYOR'S REPORT: No report.

DEPARTMENT HEAD REPORTS:

Mr. Kelly wished to address those members of Council and the public who are running for public office. He said last fall Council amended Chapter 860 regarding canvassing, soliciting and peddlers and all of those amendments were warranted. He wanted to clarify one thing for the record. The exercise of political campaigning, going door to door and leafleting are all permitted by the First Amendment and has been affirmed by the US Supreme Court repeatedly and it cannot be infringed upon by our ordinances and, in fact, it is not infringed upon by our ordinances. However, if you come to a home that says "no trespassing", don't go there. No trespassing is the exercise of the homeowner's right of privacy which trumps the right of someone canvassing. He said that there is some dicta in some of the case law that suggests that the "do not knock" or "do not solicit" list should also be observed as though it were a no trespassing sign. Mr. Nickell asked if the city has been receiving complaints of this nature. Mr. Kelly said that there was one individual who made some noise about a particular leaflet that was left in his door. Mr. Kasaris asked Mr.

Kelly to explain the meaning of "dicta". Mr. Kelly said that it is commentary by the court that does not rise to the level of the syllabus or the case law proposition. In this case, it was Watchtower Bible and Tract Society of New York vs. the Village of Stratton from 2002, US Supreme Court 122 S.Ct. 2080. In this case the dictus suggests that an ordinance that allows for a do not solicit or do not knock list should be observed.
