MAYOR'S REPORT:

Mayor Stefanik said that there will be a meeting on Thursday, March 9, 2017 at 7:00 p.m. at City Hall with the Metroparks to discuss the All Purpose Trail that will finally connect Ridge Road to Broadview Hts. on Valley Parkway. Mayor Stefanik said that part of the reason we are doing the trail is because we received a \$50,000 grant from the University Hospital Parma Medical Center a few years ago.

Mayor Stefanik said that University Hospital Parma Medical Center representatives are here this evening to update Council on some new programs and care information.

Chief Chegan provided an overview of the relationship between the Fire Department and University Hospital Parma Medical Center regarding the city's EMS services including but not limited to improved protocols, use of telemetry for the heart attack patients and other lifesaving equipment, and the continuity of care between the EMS service and hospital care. Chief Chegan introduced Joe Toth and Maureen Chase from University Hospital Parma Medical Center.

Mr. Toth, Director of EMS Education for University Hospital Parma Medical Center, gave a review of some of the classes they have conducted for our EMS department. Advanced Stroke Life Support is a brand new class in this area. He said they sent a team of instructors to all three shifts of the Fire Department and trained them. He said that the training was very well received. He said that this is another level of care that they can provide to the community.

Maureen Chase, Stroke Coordinator for University Hospital Parma Medical Center, addressed Council. She provided an detailed overview of the stroke protocol and treatment that both the EMS squads and the hospital are now following in order to reduce the damage caused by strokes. The paramedics are now able to utilize iPads to assess the patients and display those

results directly to the doctors in real time. She said that prior to this new protocol being established, the time to get to the emergency room and receive CAT scan results was 31 minutes. Now it is within 17 minutes. She said that our prior door to drug time was 41 minutes. We are now down to 25 minutes. She said that pre-hospital care is very important to the survival of the stroke patients.
