ORDINANCE NO. 13-16

AN ORDINANCE AUTHORIZING PAYMENT TO FABRIZI TRUCKING & PAVING CO., INC. FOR THE EMERGENCY REPAIR OF CULVERT #183 AT 14300 RIDGE ROAD FOR AN AMOUNT NOT TO EXCEED \$100,000, AND DECLARING AN EMERGENCY

WHEREAS: The City of North Royalton has determined that an emergency exists at 14300 Ridge Road requiring immediate repair to Culvert #183 to protect the health, safety and welfare of the community; and

WHEREAS: Fabrizi Trucking & Paving Co. Inc. has provided a quote to perform this emergency work for the amount of \$72,550; and

WHEREAS: Any additional work that is required beyond the scope of this quote will be performed at a cost of \$3,200 per lineal foot; and

WHEREAS Council therefore wishes to authorize payment for an amount not to exceed \$100,000 for this work.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. The health, safety and welfare of the citizens of North Royalton requires the emergency repair of Culvert #183 at 14300 Ridge Road, and that Fabrizi Trucking & Paving Co. Inc. has agreed to perform this emergency work in the amount of \$72,550 for the base bid, and thereafter at \$3,200 per lineal foot for an amount not to exceed \$100,000 as set forth in Exhibit A attached hereto and incorporated as if fully rewritten.

Section 2. Council hereby authorizes payment in the amount of not to exceed \$100,000 to Fabrizi Trucking & Paving Co. Inc. for this emergency work and authorizes and directs the Finance Director to provide for payment.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that it is immediately necessary to provide for payment to Fabrizi Trucking & Paving Co. Inc. for the emergency repair of Culvert #183 at 14300 Ridge Road affecting the health, safety and welfare of the citizens of North Royalton.

THEREFORE, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to council, it shall take affect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
