WHEREAS: Mr. Willey has the distinction of being the longest serving Council Representative for the City of North Royalton; and

WHEREAS: During his tenure on Council, Mr. Willey served in virtually every capacity available to Council Representatives including serving as President of Council Pro-Tem from December 2003 to December of 2005, and again from December of 2007 to December of 2011; and

WHEREAS: Mr. Willey also served as the Chairperson of the Building & Building Codes Committee, the Finance Committee, the Review & Oversight Committee, the Utilities Committee, the Issue 1 Task Force, and the Enterprise Zone Committee; and

WHEREAS: In addition, Mr. Willey served as a member of the Building & Building Codes Committee, the Finance Committee, the Review & Oversight Committee, the Safety Committee, the Stormwater Committee, the Streets Committee, the Utilities Committee and the Issue I Task Force; and

WHEREAS: Mr. Willey represented the City Council on the Planning Commission and the Recreation Board; and

WHEREAS: Mr. Willey was well known for his sense of humor and the ability to tell a great story, qualities that will be truly missed by all who knew him; and

WHEREAS: Council and Mayor Stefanik desire to recognize Mr. Willey for his community service to the City of North Royalton and to mourn the loss of a colleague and a friend.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. The Council of the City of North Royalton and Mayor Stefanik hereby acknowledge Donald R. Willey for his community service to the City of North Royalton.
