ORDINANCE NO. 15-20

AN ORDINANCE AUTHORIZING AND GRANTING THE USE OF A PORTION OF PROPERTY LOCATED AT 14788 STATE ROAD TO THE NORTH ROYALTON COMMUNITY GARDEN FOR HORTICULTURAL AND GARDENING PURPOSES ONLY, AND DECLARING AN EMERGENCY

WHEREAS: The North Royalton Community Garden provides the residents of the community with an opportunity to plant and harvest fruits and vegetables and to interact with other like minded gardeners; and

WHEREAS: A portion of the harvest is donated to the needy and seniors of our community; and

WHEREAS: Activities such as this foster a sense of community and encourage a healthier lifestyle; and

WHEREAS: The City of North Royalton wishes to support and encourage this endeavor by allowing a portion of property located at 14788 State Road to be used for this purpose; and

WHEREAS: Council desires provide for this authorization.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. The North Royalton Community Garden is hereby authorized and granted the use of a portion of property located at 14788 State Road for horticultural and gardening purposes only.

Section 2. The use of this property by the North Royalton Community Garden may be withdrawn at any time, for any reason, without notice.

Section 3. As a condition of the right to use this property, the North Royalton Community Garden shall provide all required insurance, waivers and releases, and any other requirements as may be required by the Director of Law.

Section 4. This Ordinance shall supersede all previously adopted Ordinances in direct conflict herewith.

Section 5. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 6. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that it is immediately necessary to authorize and grant the use of a portion of property located at 14788 State Road for horticultural and gardening purposes only to the North Royalton Community Garden.

THEREFORE, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
