AN ORDINANCE AMENDING THE CODIFIED ORDINANCES OF THE CITY OF NORTH ROYALTON, PART 12 PLANNING AND ZONING CODE, CHAPTER 1284 SIGNS, BY AMENDING SECTIONS 1284.03, 1284.04, 1284.11, 1284.12 AND REPEALING SECTIONS 1284.05 AND 1284.06, AND DECLARING AN EMERGENCY

WHEREAS: It has been determined to be necessary to amend Chapter 1284 Signs of the Codified Ordinances of the City of North Royalton in order to update the provisions which govern signs throughout the community; and

WHEREAS: It is therefore necessary to amend Sections 1284.03, 1284.04, 1284.11, 1284.12 and repeal Sections 1284.05 and 1284.06; and

WHEREAS: Council desires to provide for these amendments.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. Part 12 Planning and Zoning Code, Chapter 1284 Signs, Sections 1284.03, 1284.04, 1284.11, 1284.12 of the Codified Ordinances of the City of North Royalton are hereby amended in their entirety as outlined in Exhibit A attached hereto and incorporated as if fully rewritten.

Section 2. Part 12 Planning and Zoning Code, Chapter 1284 Signs, Sections 1284.05 and 1284.06 of the Codified Ordinances of the City of North Royalton are hereby repealed.

Section 3. Chapter 1284 of the Codified Ordinances of the City of North Royalton is hereby amended as provided for herein and all other provisions of Chapter 1284 shall remain in full force and effect.

Section 4. This Ordinance shall supersede all previously adopted Ordinances in direct conflict herewith.

Section 5. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 6. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that it is immediately necessary to amend Chapter 1284 Signs of the Codified Ordinances of the City of North Royalton in order to update the provisions which govern signs throughout the community.

THEREFORE, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
