

# THE CITY COUNCIL OF NORTH ROYALTON, OHIO

AN ORDINANCE AMENDING THE CODIFIED ORDINANCES OF THE CITY OF NORTH ROYALTON, PART EIGHT BUSINESS REGULATION AND TAXATION CODE, BY CREATING A NEW CHAPTER 880 ENTITLED USE OF PUBLIC WAYS FOR SERVICE PROVIDERS, AND DECLARING AN EMERGENCY

WHEREAS: Increasing demand is being made on the city's streets and rights of way to accommodate facilities of telecommunications, small cell, Digital Antenna System providers and other service providers; and

WHEREAS: It is in the city's best interest to manage the occupancy and use of the city's streets and rights of way by telecommunications, small cell, Digital Antenna System providers and other providers to the extent permitted by law; and

WHEREAS: Council desires to provide for this amendment.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

Section 1. Part Eight Business Regulation and Taxation Code of the Codified Ordinances of the City of North Royalton is hereby amended by creating a new Chapter 880 Use of Public Ways by Service Providers, a copy of which is attached hereto as Exhibit A and incorporated as if fully rewritten.

Section 2. Part Eight Business Regulation and Taxation Code of the Codified Ordinances of the City of North Royalton is amended as provided for herein and all other provisions of Part Eight shall remain in full force and effect.

Section 3. This Ordinance shall supersede all previously adopted Ordinances in direct conflict herewith.

Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 5. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that it is immediately necessary to amend Part Eight of the Codified Ordinances of the City of North Royalton in order to manage the occupancy and use of the city's streets and rights of way by service providers and other providers to the extent permitted by law.

THEREFORE, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
